- 2(c) The use of names of towns, places, countries, notable persons, common names, or names that are misleading as to sex, origin or relationship, may be refused.
- 3 No Tasmanian born cat shall be registered unless the litter in which it was born is recorded and the breeder has registered a Stud prefix, unless the special permission of the C.A.T. Inc is obtained.
- 4 Interstate and overseas born cats must be registered on the full register of the Control Body in the State or Country where born. Unless the original or completed transfer certificate is enclosed, this form must be completed by the interstate Control Body before the transfer will be accepted.
- 5 Applications for registration of cats shall only be accepted for breeds recognised by the Committee of the C.A.T. and such application shall only be accepted if the breeder's declaration is signed by the breeder.
